In consideration of being allowed to participate in any way in the Skating program, related events and activities of Flint Iceland Arenas and Iceland Competitive Edge Figure Skating Club, I

the undersigned, acknowledge, appreciate, and agree that:

1. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. I knowingly and freely assume all such risks, both known and unknown of my participation in ice skating programming, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation in ice skating programming. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest person in charge immediately; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS THE Flint Iceland Arenas, Iceland Competitive Edge Figure Skating Club, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

Furthermore, the novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and spreads from person-to-person contact.

Flint Iceland Arenas has put in place preventative measures to reduce the spread of communicable diseases; however, we cannot guarantee that you or your child(ren) will not become infected while attending our facilities. While we've implemented reasonable preventive measures, we depend on each and every visitor and their families to follow the guidelines from the Center of Disease Control, and all applicable federal, state, and local health department guidelines, rules, laws, and regulations before and while visiting our premises. We are all in this together and rely on each other to adhere to the above-mentioned guidance and legal restrictions. The undersigned fully understands and acknowledges both the known and potential dangers of utilizing our facilities, services, and programs and acknowledge that use thereof by the undersigned and/or such participating children may, despite our reasonable best efforts to mitigate such dangers, result in exposure to communicable diseases, which could result in quarantine requirements, serious illness, disability, and/or death.

RULES FOR FIGURE SKATING:

- **You will enter the facility through the side door into the lobby where skate rental is located. One door will be deemed entrance, one exit.**
- **The skater or parent/guardian must sign in each time they come to the rink, with the names of the people entering and phone numbers in the event you need to be reached for contact tracing.**
- **You will arrive dressed in your skating clothes, no changing outfits in the bathroom.**
- **If possible, put your skates on in the car prior to arriving at the rink, and enter wearing your skate guards.**
- **Skating session are available for purchase ONLINE only at entryeeze.com.**

- For the time being, sessions are 55 minutes long. Skaters can purchase one 55-minute session, or two back to back. You must exit the ice immediately when your 55 minutes is up.
- If the second session is not at maximum capacity, and you/your skater would like to skate longer, you can pay the drop-in fee for the second session by CHECK ONLY made out to ICEFSC. This is the only exception to online registration. The check can be placed in the ICEFSC drop box in the lobby where you entered. Please put the date and time of the session in the memo line.
- Sessions are capped at 15 skaters maximum, not including coaches.
- Guest skaters from other clubs, or who are USFS members, may skate 3 sessions, before we require purchase of a second club membership to ICEFSC
- Social distancing, to the best of everyone's ability, will be practiced on the rink while skating. We understand that sometimes the patterns of a skating session lead to skaters briefly passing each other on the ice. There is no lingering with friends on the boards. Communications with coaches should be from 6 feet away.
- You cannot arrive in the building more than 10 minutes prior to the start of your session. You must exit the ice immediately when your 55-minute session is over. You will have and have 10 minutes to take your skates off and depart the facility.
- You may only change skates in the lobby where you enter, socially distanced. You may not put skates on or take them off on benches located inside the rink.
- No more than 2 parents/guardians are allowed in the facility with a skater. Once the parent or guardian has helped the skater put their skates on, they can watch socially distanced, ONLY from the bleachers.
- All skaters, parents, and guardians must wear a facial covering (i.e., mask) over their mouth and nose at all times in the facility, even while skating. Medical exceptions will apply.
- Skaters can bring water out to the rink and can briefly remove the mask for a drink but must put it back on immediately.
- No food will be allowed to be eaten in the building unless there is a medical reason why it is needed.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT. I HAVE ALSO READ, UNDERSTAND, AND WILL ABIDE BY THE RULES FOR FIGURE SKATING.
